SCHOOL SAFETY

RECESS

All children are expected to go outside during recess breaks except in the case of inclement weather. Please ensure your child dresses appropriately for the weather. Students generally remain indoors if the weather is -21 degrees Celsius or colder, with discretionary judgement.

ATTENDANCE AND CHILD SAFETY

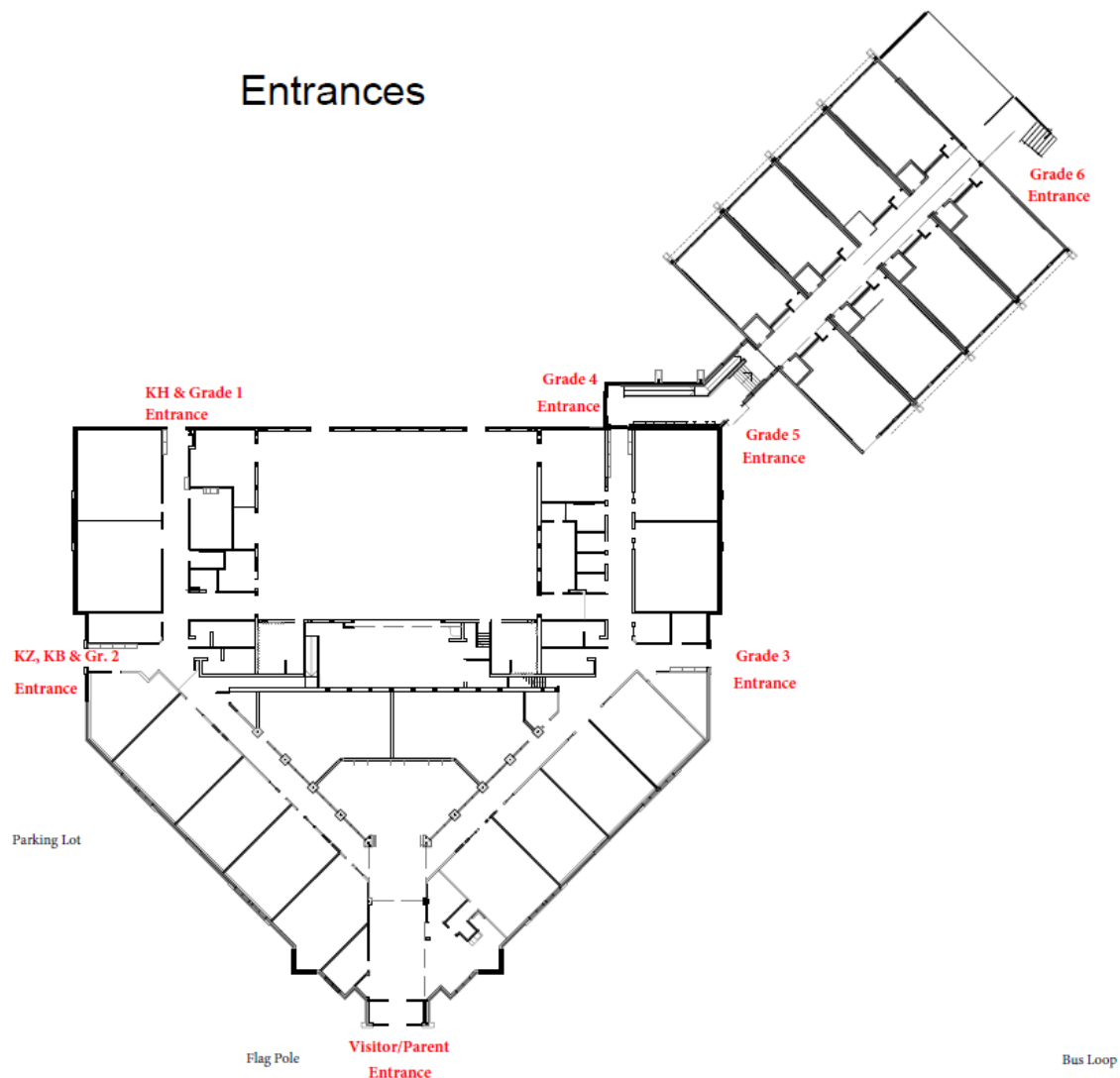
Parents are asked to call the school at 403-652-2889 or email HSA-Attendance@redeemer.ab.ca if their child will be away for any reason. Absences can be submitted at <https://holyspirit.redeemer.ab.ca/attendance>. Please notify the Office if you are planning a long-term holiday and/or absence. If a student is absent and the school has not been notified, parents will be called. This is done to take every precaution to protect our students.

LATES AND ABSENCES

Students are expected to be on time for school and all classes. Chronic absences and lates put any child at risk and habitual lates interrupt class instruction. It is important for children to recognize the importance of attendance and arriving to school on time. Habitual lates and absences will result in discussion and/or consultation with parents and/or Christ the Redeemer Attendance Office, and the Alberta Education Truancy Board.

STUDENT DROP OFF / PICK UP

To ensure that classroom instruction is not interrupted, and for the safety of our students, parents are asked to adhere to the following rules when picking up their child:



Late Morning Arrival

If dropping your child off later than 8:45 A.M., please accompany your child into the school and sign him/her in at the office. We ask you to do this to ensure the school is aware the student is at school and accounted for. Students arriving late will be required to get a stamp at the office, letting the teacher know that they have checked in.

Appointments & Pick-Up During The Day

1. Parent to check in with receptionist who will call the classroom to have the child sent to the office.
2. The office will sign your child out. If your child returns, accompany him/her back into the building and sign them in.

If Your Child Becomes Ill

If a student becomes ill during the day, a parent or guardian will be asked to pick them up as the safest place for an ill student is at home.

SUPERVISION

School supervision by staff begins at 8:30am and ends after the busses have left at 3:45. Students who walk to school are asked to arrive no earlier than 8:30. Supervision during recess and noon hour is provided by an adequate number of staff members at all times.

EMERGENCY PROCEDURES

In the case of an emergency situation, the school will implement a telephone fan out system that will be used to contact parents. All parents will be informed of the nature of the emergency and the school's action plan to deal with the situation. As a proactive measure to an emergency situation that requires the school to be evacuated, we will have a minimum of six evacuation drills as well as a number of school lock-down exercises. These will provide the students and staff the opportunity to become very familiar with the routine and expectations in the event there is a real emergency. CTR utilizes a text message system to alert parents during emergency situations.

CELL PHONES AND CAMERAS

We are asking your help in ensuring that your child does not take their phone or camera to school to take pictures of their friends. We want to ensure that photos or videos of students will not end up on the internet unknown to them or their parents. Secondly, we ask that cell phones remain turned off and in your child's backpack from the moment they step onto the bus in the morning until they get off the bus at night. All classrooms have phones and there are several at the office your child is welcome to use, with their teachers' permission.

MEDICAL ALERT AND ADMINISTERING MEDICATION

There are several students in our school who have severe allergies or medical problems. One identified condition at our school is anaphylaxis (severe allergic reaction to peanuts, citrus fruit, shellfish, or bee stings). The most common form of this in our school is an allergy to peanuts. To decrease the likelihood of an emergency medical situation, our school will strive to create a safe environment for these students. Therefore, we have made our school a **“nut-free zone”**. Please refrain from sending foods containing nuts or peanut products to school. The administering of medication to a student is the responsibility of the students' parents and physician. If possible, medication schedules should be arranged so that students take the medication at home. When no other viable alternative exists to a student requiring medicine during the school day, school staff may be requested to provide such assistance in accordance with Board Policy. All requests for the administering of medication to students shall be made through the office. The office will require a signed request from the parent and physician indicating the type of medication to be administered, time, and manner of administration, required dosage, and action to be taken in the event of possible hazard of side effects.

COMMUNICATION

STUDENT ASSEMBLIES

At selected times throughout the year, the school will meet as a single body to celebrate academic achievements (curriculum sharing, class projects), spiritual celebrations (Liturgies, Remembrance Day), individual talents, and student accomplishments (talent shows, awards). Parents will be informed of the times of these assemblies, and they will be posted on the calendar on our school website.

REPORT CARDS

Report cards are a formal method of communicating your child's progress. We ask that you discuss your child's report card with them. Report cards will be available online on Friday, November 15, 2024, Friday, March 14, 2025, and Wednesday, June 25, 2025.

PARENT/STUDENT/TEACHER INTERVIEWS

We encourage our teachers to make parental contact when student successes and problems arise. We also believe that it is of utmost importance that parents initiate contact with the school if they have any concerns.

Parent/Teacher/Student Interviews have been set for the following dates: Thursday, November 21, 2024, from 1:00 until 9:00 p.m., and Thursday, March 20, 2025 from 4:00–9:00.

AGENDA COMMUNICATION BOOKS

The main form of communication between the school and the home will be through the use of the Student Agendas. Each day the students will be required to write in the books highlighting important information, upcoming events, and homework assignments. The teachers are required to check the agendas on a regular basis and will write notes when required to the parents. We encourage all parents to use the agenda books to communicate any minor concerns or questions to the teacher.

SCHOOL NEWSLETTER

The school newsletter will be emailed on the first school day of each month. The purpose of the newsletter is to inform parents of the special happenings and upcoming events for the school.



CLASSROOM CURRICULUM LETTER

At the beginning of each month, teachers will be emailing home a curriculum letter that outlines the activities, themes, and objectives for each of the core subjects that will be studied that month.

DISCIPLINE POLICY PREAMBLE

Christ The Redeemer Catholic Schools Discipline Goal Is To Build A Caring Culture Within Our Catholic School Community, Where Students, Staff, And Parents Encourage, Value, Support, And Feel Safe.

Christ the Redeemer Catholic Schools and Holy Spirit Academy believe that Catholic values provide the foundation for promoting a safe, secure, caring school environment. We believe that the basic long-term purpose of discipline is development of the capacity for self-control leading to self-direction, leadership and discipleship. This policy has been developed in accordance to the Code of Student Conduct as stated in the School Act and Christ the Redeemer Catholic Schools' Policy for Safe and Caring Schools.

Section 12 Of The School Act States: A Student's Conduct Must:

- 3.1.1 Be diligent in pursuing his /her studies.
- 3.1.2 Attend school regularly and punctually.
- 3.1.3 Cooperate fully with everyone authorized by the board to provide education programs and services.
- 3.1.4 Comply with the rules of the school.
- 3.1.5 Account to his/her teachers for his/her conduct.
- 3.1.6 Respect the rights of others.

STUDENT CODE OF CONDUCT

STUDENT BEHAVIORS

Behaviors ranging from **verbal** (name calling, teasing, gossiping, manipulating, threatening, extortion, etc.), **physical** (pushing, kicking, defacing property, threatening, etc.), and **relational** (gossiping, ignoring, isolating, excluding, shunning, rolling of eyes, sighs, etc.) will be addressed. Administration and/or teachers will intervene whenever such behavior is witnessed or reported. Depending on the intent, severity and frequency of these behaviors, escalating consequences will apply.

CONSEQUENCES AND INTERVENTIONS

Students are responsible for their behavior and any behavior that disrupts or distracts from the educational atmosphere of our school is unacceptable. The expectation is that students will follow reasonable rules and regulations, which are in place to benefit all the students in the school community. It is an expectation that all students will behave in a manner that is courteous, respectful and in accordance with the goals of Catholic education. When the conduct of a student is detrimental to him/herself, others or the school, or when a student refuses to comply with defined expectations, corrective measures will be taken with the expectation that parents will support school discipline procedures.

HOME AND SCHOOL COMMUNICATION

Parents who wish to discuss a matter of student conduct or discipline should first contact the child's teacher. Further inquiries should then be addressed to Holy Spirit Academy Administration. If the matter cannot be resolved by Administration, the parent/guardian may contact the Superintendent.

ATTENDANCE

Attendance is monitored daily and students are required to attend school consistently. Parents will be contacted to discuss students' attendance when attendance is irregular and absences are deemed excessive.

DRESS CODE

All students are expected to dress in a manner that is not degrading to the student or the nature of our Catholic school. Students are asked to dress appropriately for the weather. The following clothing has been determined unacceptable at Holy Spirit Academy; revealing or see-through clothing and clothing with inappropriate slogans, words or pictures. Students will be asked to call home for appropriate school attire. Jackets or hoods are not to be worn during class time. All students are required to have a pair of indoor gym shoes. Hats and caps are to be removed before entering the school building and hung on their coat hook.

PROHIBITED ITEMS

Laser pens and any item deemed dangerous (knives, guns, lights, etc.) are banned. Smoking, vaping, and/or being under the influence or possession of drugs or alcohol on school property is prohibited.

RESTRICTED SCHOOL ITEMS

The following items will be stored in student knapsacks during the school day: ALL PERSONAL ELECTRONIC DEVICES (including games, cell phones, audio players, etc.) The school will not be responsible for lost, stolen or damaged personal items.

CTR TRANSPORTATION POLICY

BUSES

Christ the Redeemer Catholic Schools has a contract with Southland Transportation to provide bussing for students. Bus routes have been determined in consultation between the bus company and our district office, taking into account the safety of students, rider-ship time and economics. Should you have questions or concerns, please contact Vanessa Douville at our Central Office (403-938-2659). Bus families are asked to download the *Stopfinder* App.

BUS PROCEDURES

The buses will drop passengers off in the bus loop each morning and students will proceed to the assigned student doors. Adult supervisors from the school will be present. Bussed students are to go immediately to their bus after end of day dismissal. The buses will depart as soon as loading and checking student attendance is complete and it is safe to proceed. Supervisors are present to ensure a safe and orderly loading takes place. Parents should communicate directly with the bus driver and the school's office regarding times the student will not require bus transportation (e.g. sickness). In the afternoon all students must be accounted for before each bus leaves. **If a student will not be riding the bus, parents are asked to call the office.**

STUDENT BEHAVIOR EXPECTATIONS

The behaviour of students on the bus is generally the bus driver's responsibility. If a student has a chronic behaviour problem or if the student commits a major infraction of the rules, the bus driver will communicate concerns with the school's administration and contact parents. The principal may suspend a student from riding the school bus should behaviour warrant this. TRANSPORTATION SHUTDOWN

School bus operation may be cancelled when road or weather conditions are hazardous and constitute a safety risk to students. School closures are posted on the CTR website by 6:00am <http://www.redeemer.ab.ca/> click on the **Transportation Tab** then the **Bus Route Status Tab**. Every effort will be made to contact all parents prior to dismissing students should an early dismissal be necessary.

STUDENTS WALKING & BIKING

Students walking to school are asked to use the sidewalks and to cross the street in a safe manner and then proceed directly to their door at the school. Students who ride their bike or skateboard to school must obey all traffic laws including the mandatory wearing of helmets. Students are asked to walk their bikes on the school sidewalks during school hours. Once on school grounds, students must secure their bikes.

SCHOOL PROGRAMS

HOME READING PROGRAM

There are many important factors which contribute to improving student achievement. One is parental involvement in their children's education. A second is the development of good work and study habits for students at home. Third is the development of communication skills such as reading and writing. The Home Reading Program helps develop all these skills. We see this program as a positive step in enhancing your child's education and trust you will cooperate fully in the organization and implementation of it. Each student who attends H.S.A. will participate in Home Reading as part of their Language Arts Program.

HOMEWORK POLICY

Homework is an integral part of the learning process and has many purposes. It is an extension of what has been taught in the classroom. It develops effective work/study habits and routines. It provides students with an opportunity to practice skills, and it is a valuable connection between teacher and parents. It also allows parents to become actively involved in their child's education. The following are some guidelines developed by the staff of H.S.A. These sound practices are based on current educational research:

1. Ten minutes of homework per grade level is an appropriate amount of time for students to spend on homework each night. Therefore, you would expect **Grade 1&2** to do about 10-20 min/night, **Grade 3&4** – 30-40 min/night, **Grade 5&6** – 50-60 min/night. This time includes the home reading time. Parents are encouraged to provide their children with a homework area and monitor their child's work.

2. The focus of homework in **Division I** is to develop solid **literacy skills** in all students. Therefore, nightly reading practice to an adult is essential for success. Other types of homework coming home may include test preparation, practice for mastery, and unfinished classroom work.
3. The types of homework coming home for students in **Division II** may include test preparation, practice for mastery, and unfinished classroom work. Mastery of literacy skills continues to be a priority at this level, therefore; nightly home-reading remains an expectation for all students in Grades 4-6.
4. Parents are not teachers, generally, and we will not ask or expect you to teach your child complex concepts. We do ask that you encourage your child to complete their homework, and then let the classroom teacher know if they are unable to do so.

LIBRARY

The school's library provides curriculum materials and recreational reading for students' use during class time. Each student will have the opportunity to sign out a book once a week. Students are responsible for overdue, damaged or lost library material.

EXTRA-CURRICULAR CLUBS

The school is committed to providing the students with a wide variety of extracurricular activities that will enhance their school experience. The school will operate clubs that are formed based on student and teacher skill and interest. The focus of all extracurricular clubs is to provide students with opportunities to develop skills in specific areas. As these clubs are dependent on the teachers' participation, all school rules will be in effect during their operation.

PARENTS IN THE SCHOOL

VOLUNTEERS

At Holy Spirit Academy we welcome and encourage our parent community to become involved in volunteering at the school. All parent volunteers will be asked to read our **Volunteer Program Handbook** and sign the **Volunteer Confidentiality Form**. A variety of volunteer opportunities exist at HSA.

SCHOOL COUNCIL

The school council is an advisory group who consults with the principal on issues at the school and meets on a bi-monthly basis. School Council meetings are combined with HSA Fundraising Society meetings

Student Covenant
